Once seated 6 feet apart in the counselor's office, the counselor and child can remain masked or Either/ both can be removed for the session and returned after the appointment. Please check the following box to state your preference for your child's session:

I understand that the risk of becoming exposed to or infected by COVID- 19 at or around the Daystar offices may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Daystar employees, volunteers, and clients and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself, including, but not limited to, personal injury, disability, and death, illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s participation in counseling or programs at or around the Daystar offices at any time today or hereafter ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless Daystar, its employees, agents, officers, directors, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs, attorneys fees, or expenses of any kind arising out of or relating thereto.
